Payment Policy

Our policy requires that all accounts be cared for, in full, at the time of arrangements. Acceptable forms of payments include: Cash, Check, Money Order, Visa, and Master Card.

There will be a 3% surcharge for all cash advance items and sales tax when account is paid by credit card.

Basic Services of Funeral Director and Staff.....\$895

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee includes the following: staff available to respond to the funeral arrangements you select. This fee includes the following: staff available to respond to the initial call for service, 24 hours a day, 365 days a year. Arrangement conference, coordination of service plans with the cemetery, crematory, clergy, and/or other parties involved in the final disposition. This fee includes a proportional share of the business and administrative expenses i.e., insurance, utilities, licensing, and governmental compliance costs. This fee is already included in our charges for the direct cremation.

Embalming.....\$495

Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Forwarding Remains to another Funeral Home.....\$1,900
This charge includes removal of remains, basic services of staff, embalming, necessary authorizations, and local transportations to airport. This fee does not include visitation, rites, or ceremonies prior to forwarding the body.

Receiving Remains from another Funeral Home.....\$1,400
This charge includes basic services of funeral director, staff, overhead, transportation of remains to the funeral home, sheltering of remains (one day), casketing, and transportation to a local cemetery. This charge does not include any other preparation, viewing, services, filing fee, or casket.

Immediate Burial.....\$1,800
This charge includes basic services of funeral director, staff and overhead, transfer of remains to the funeral home, sheltering of remains (one day), casketing, and transportation to a local cemetery. This charge *does not* include other preparation, viewing, services, filing fee, or the casket. Please refer to our Casket Price List and/or showroom to select a casket.

Direct Cremation

This charge includes basic services of funeral director, staff and overhead, transfer of remains to the funeral home, sheltering remains (one day), and transportation to a local cemetery or crematory.

If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be made of materials like cardboard, fiberboard, or composition of materials (with or without an outside covering). The containers we provide are cardboard containers.
